Regular Board Meeting San Miguel Senior Center Minutes of November 12, 2025

The meeting was called to order at 6:00 pm by President Tracy, followed by the Pledge of Allegiance.

Will the General Manager please call roll. All members of the board are present. A quorum was confirmed.

Public Comment on matter not on the agenda there were none.

Minutes: Are there any corrections or additions to the minutes of October 8, 2025? Being none, President Tracy made a motion to approve, a second by Vice President Hamson. All were in favor. Motion carries.

Financial Report: Are there any questions concerning the financial report? Being none. Vice President Hamson made a motion to approve the financial report, a second by Director Stark. All were in favor. Motion carried.

Correspondence:

Cal OES IRCSD Extension

President Tracy gave update on Cal OES (Office of Emergency Services) IRCSD time extension requests for PW2178 for DR-4683 storm damage during the period of December 2022 – January 2023. There are 4 projects, which have been previously proposed. The replacement of the culvert at Hawk Ridge and Falcon Way with a Arizona Crossing; restore Hawk Ridge Pl at Golden Eagle, back to its pre-disaster design, replace surface utilizing chip & seal, replace base utilizing gravel, replace subbase utilizing fill clay within existing footprint; restore Bald Eagle at Gray Hawk Way, back to its pre-disaster design, replace surface utilizing chip & seal, replace base utilizing gravel, replace subbase utilizing fill clay within existing footprint; Restore Independence Ranch at Hog

Canyon, back to its pre-disaster design, replace surface utilizing gravel. Fema used Cal Trans estimates

V. President Hamson said our road are our first priority and they need to be maintained, but we have to put the money out first and then FEMA will reimburse. The projects cannot be changed because of the project application that was done at the time.

Director Costello does the Arizona Crossing include paving? Answer: it is not mentioned in the project review list.

Toni Reis – when will the work be done? President Tracy explain the OES/Fema timeline.

Director Stark noted that just to do Hawk Ridge at Falcon it is \$13,097.50; Hawk Ridge at Golden Eagle is \$9,455.06.

After lengthy discussion between the Board and residents in attendance the Board decided to ask for an extension until December of 2026

California Special Districts Association Annual Membership dues – Director Costello made a motion to approve to pay the annual dues for 2026, a second by V. President Hamson. All were in favor. Motion carried.

Emails from Mr. Miller and Concerned Citizens: V. President Hamson voiced his concerns regarding the latest email received (the Addendum to Formal Complaint – subject: Expand Conflict of Interest Findings - Bald Eagle Road Project (October 2025)). Director Mulcahy voiced his opinions on the email's while stating over 40 complaints were received on the last board and nothing was done, he further stated that that we did not press the issue with last board. Director Mulcahy noted that our attorney should and will advise us on what do to. Director Costello noted that we need to do something,

Residents in attendance stated that Charles is making the IRCSD spend unnecessary money when it could be used on our roads. There was further discussion on the roads from all residents in attendance. Richard asked if Ramsey Asphalt could provide a statement of fact regarding the work that was done. V. President Hamson will contact Ramsey.

MANAGER'S REPORT

Dear Ms. Bonebrake:

This firm has recently been retained to advise the Independence Ranch Community Services District ("District") regarding the above-referenced matter, and related issues. The District is a very small community services district in San Luis Obispo County, with only one part-time staff person. We are in the process of reviewing the complaint(s) filed by Charles Miller, along with the facts and history of the District's assessment, and some relatively recent asphalt repair work that the District completed.

Because the District has a limited staff, the main purpose of this letter is to provide you and your staff with a contact for the District, in case we can be of assistance. The District will cooperate with your investigation, as well as with any other official inquiry that may be initiated, but would prefer that any communication to the District come through me. Please note that we represent the District itself, and we do not represent any individual.

With regard to Mr. Miller's most recent submittal to your office, dated November 12, 2025, please consider three clarifications or corrections on behalf of the District:

1) The District's responses to Public Records Act requests from Mr. Miller do not constitute "evidence" as he has claimed. Further, the fact that the District did not provide records he believes should exist is not "evidence" of wrongdoing. He made specific requests to the District and the District provided responsive records. To my knowledge, Mr. Miller did not request a "prioritization plan," as referenced in his complaint.

- 2) Mr. Miller's complaint alleges, under Item II, a "Disproportionate Use of Public Funds," but provides no citation to any law that requires any "proportionate" expenditure of public funds. More important, regarding the District's work he claims occurred between October 20 and 24, 2025, he does not allege a violation of any law over which the FPPC has enforcement authority. At best, this particular allegation is a political dispute and has no bearing on the "conflict of interest" allegation he has raised.
- 3) It is unclear why FPPC's November 14, 2025 letter was also directed to Greg Hamson. The single violation alleged is a single conflict of interest violation under Government Code Section 87100, et seq. by George Tracy. There is no allegation in Mr. Miller's submittal that Mr. Hamson had any conflict of interest in a governmental decision (if there was one) to repair the roadway on Bald Eagle Road. There also is no allegation that Mr. Hamson has any property or other financial interest that would have been materially affected by this work. This distinction is important to the District, because the person who Mr. Miller alleged had a conflict of interest in this matter did not participate in the direction of the contractor. As noted above, without full-time staff, Board members in small community services districts must occasionally perform functions more typically performed by staff in larger entities. The complaint does not allege, or provide any evidence, that Mr. Hamson had a conflict of interest.

I appreciate the opportunity to provide this information on behalf of the District. Please contact me if you need any additional information from the District.

Dear Charles Miller:

This letter is in response to the sworn complaint you submitted to the Enforcement Division of the Fair Political Practices Commission regarding the above-named individuals. The Commission only has authority to enforce the provisions of the Political Reform Act (the "Act") found in Government Code Sections 81000, et seq. Under the Act, a public official has a disqualifying conflict of interest in a governmental decision if it is foreseeable that the decision will have a material financial effect on their personal finances or other financial interests distinguishable from the effect on the public generally. The financial effect of decisions involving the replacement or maintenance of existing streets are not considered material under California Code of Regulations, Title 2, Section 18702.2(d)(1). Additionally, the Act does not regulate the general misuse of public funds. Therefore, the Enforcement Division will not pursue an enforcement action in this matter. 
