Meeting called to order 6:35 P.M.

Pledge of Allegiance/Roll Call: Terry Leezer, Patti Claude, John Hunter and Mark Kenyon present, Kerry Davenport- General Manager- Present

Public Comments: Mark Ciampa, and Ken Reed present.

Approval of Agenda: Patti Moved and Terry seconded a motion to approve the Agenda. Carried unanimously.

Approval of 1/13/21 Minutes: Patti moved and Terry seconded a motion to approve the Minutes. Carried unanimously.

Approval of Treasurer's Report and Financials: Mark moved and Patti seconded a motion to accept the Financials. Carried unanimously.

By-Law Review postponement. Mark and John commented this was postponed without their participation. Terry stated he had just received advise from the county to do nothing until 90 days after Cinde had been asked to resign. Mark commented that could have been done at the meeting.

Mark commented he had found a friend of his from Templeton who would do the job for \$50. a month and had in fact, already with Mark giving him the password, installed the February agenda on the website.
