Minutes

Are the any additions or corrections to the minutes of August 13, 2025? Being none. Vice President Hamson made a motion to approve the minutes, a second by Director Costello. Motion carried

Financial Report

Are there any questions concerning the financial report? Being none. Vice President Hamson made a motion to approve the financial report a second by President Tracy. Motion carried.

Public Comment

Richard Solis asked about Charles Miller and what is going on? it was noted that since it was not on the agenda we were not able to talk to about it at this time; Frank Blumling asked about the new tax assessment when will the CSD receive it? President Tracy explained how the tax assessments are received from the county; by a lump sum, monthly, quarterly or when a resident sells their property, money can trickle in at all times. Frank Blumling asked how much money will the CSD receive after the 218 vote was approve to raise the special tax assessment. President Tracy responded with \$125,000, before the raised tax assessment it was \$62,500. The increase was \$500 per property owner. Director Mulchay noted that not all money will be dedicated to road repair, money is still owed on the USDA loan

Correspondence

General Manager – we received correspondence from SDRMA (Special District Risk Management Authority) on receiving the President's Special Acknowledgement Award – Property/Liability Program. On achieving no paid claims for the Property/Liability Program years 2020-2025.

Unfinished Business:

Vice President Hamson discussed again from last month the road repairs and estimates. Vice President Hamson talked with Viborg, Tatum & Faravanti they said they were not interested or were too busy to do the job, he tried to contact Freedom Construction and received no response back. Two (2) bids were received from Ramsey Asphalt and Apodaca Paving. Discussion was made regarding both companies. Apodaca will only do Hot Mix Asphalt – Patching for \$27,500; Ramsey will clean and kick broom roads, patch with hot asphalt, double chip seal, clean & prepare surfaces and fog seal for \$35,000.

Frank questioned Ramsey's estimate. How many tons of asphalt? Answer was given 50 tons.

John can you go back to Apodaca and ask if they will chip seal?. Answer – they will not, they will only hot patch.

Frank questioned – when could the repairs start? Vice President Greg said; we could have done within the next couple of months.

A motion was made by Director Costello, a second by Director Mulchay, to have Vice President Hamson contact Ramsey Construction and to move forward with road repairs. There being no further discussion, all were in favor.

Frank said he wanted to complement Greg Hamson and Dena Price for all the hard work they did on putting all the information together regarding the 218 vote and mailing everything out at their expense.
